Monthly inquiry for accommodation statistics

Dear respondent

Your company has been selected for the monthly inquiry for accommodation statistics. In the inquiry, information is asked about accommodation establishments' capacity, sales income from accommodation and overnight stayers by country of residence. In addition, basic data and permanent capacity related to accommodation establishments are inquired. We cannot obtain data on establishments from elsewhere, e.g., from administrative registers. The obligation to provide data is based on the Finnish Statistics Act (280/2004).

Data are collected from accommodation establishments with at least 20 beds or caravan and camper pitches with electrical connection points. The inquiry comprises approximately 1,400 accommodation establishments.

How to respond

Log in to the form using the login identifiers in the top right-hand corner of this accompanying letter. You can also send monthly data as a direct transfer from your customer management system if your software has this feature. Please check annually basic data as well as the capacity data on your accommodation establishment.

Instructions for responding can be found on the web form and on the data collection page stat.fi/en/surveys/maj#instructions.

We ask for your response by 6th of each month.

What are the data used for

The collected data are used monthly for producing accommodation statistics: stat.fi/en/statistics/matk. Corresponding data are collected in all EU countries and they are part of the European Statistical System. Data is needed to monitor and promote domestic tourism and tourism from abroad to Finland.

We send quarterly data supplier feedback to the establishments that have responded to the inquiry on time. In the feedback, the establishment's data are compared with similar establishments both nationally and regionally.

Further information on the obligation to provide data and treatment of the data

Confidentiality, data protection and publicity

Statistics Finland uses the data for the compilation of statistics. Unit level data collected for statistical purposes must be kept confidential by virtue of Section 24, Paragraph 1, Sub-paragraph 16 of the Act on the Openness of Government Activities (621/1999). According to Section 13 of the Statistics Act (280/2004), Statistics Finland may also release data for scientific studies and statistical surveys without data enabling direct identification.

Statistics Finland may release data with their identification data to another Finnish statistical authority for the purpose of compilation of statistics on an activity falling within its sphere of influence, for cooperation between national statistical institutes, for cooperation between national statistical institutes, to the EuroGroups Register of multinational enterprises and to the Bank of Finland for the development, production, and quality improvement of the European statistics for which it is responsible. The data are protected against unauthorised access in accordance with the data protection rules adopted by Statistics Finland. The Statistics Act prohibits the use of data collected for statistical purposes in an investigation, surveillance, legal proceedings, administrative decision-making, or other similar handling of a matter concerning the enterprise. Unit-level data on enterprises may only be handled at Statistics Finland by persons whose tasks require the use of such data. Obligation to provide data

The obligation to provide data is based on Sections 14 and 15 of the Finnish Statistics Act (280/2004). Notwithstanding the provisions on data secrecy, entrepreneurs are obliged to provide Statistics Finland with such data that are necessary for the compilation of statistics. By virtue of Section 21 of the Statistics Act, Statistics Finland is entitled to receive these data free of charge. By virtue of Section 8 of the Statistics Act, data providers have the right to seek exemption from the obligation to provide data wholly or partially if the provision of data causes the respondent unreasonable inconvenience and the exemption will not essentially hamper the production of statistics or weaken the reliability and usability of statistics. Unreasonable inconvenience refers to putting the respondent in an unequal position with regard to other data providers. Duration of storage

Digital statistical data formed from the supplied data are permanently stored at Statistics Finland in accordance with the National Archives of Finland's confirmed storage period decision (KA/19843/07.01.01.03.01/2017).

About the data collection

The accommodation statistics are based on Regulation (EC) No 692/2011 of the European Parliament and of the Council concerning European statistics on tourism that obliges the Member States to compile uniform statistics on the supply and demand of tourism.
