Quarterly inquiry on financial assets and liabilities 2024

The inquiry collects information on financial assets and liabilities (intra-group and non-group) of Finnish enterprises and entities at the quarterly level.

The data are collected from the largest enterprises and entities operating in Finland, which have significant foreign or domestic financial assets and liabilities. The inquiry covers all domestic sectors (excl. financial institutions, investment funds, insurance corporations, households and employment pension schemes). The sample size is around 130 enterprises/entities.

How to respond

Please respond with the electronic form. The Internet address of the inquiry and the login identifiers for your enterprise are in the top right-hand corner of this letter. You can also utilise the Suomi.fi authorisation service by The Digital and Population Data Services Agency. Statistics Finland's Suomi.fi mandate is responding to data collections from enterprises and organisations. The collected data are used for the compilation of statistics on balance of payments and international investment position and statistics on foreign direct investments. In addition, the data are utilised in compiling National Accounts.

Further information on the obligation to provide data and treatment of the data

Confidentiality, data protection and publicity

Statistics Finland uses the data for the compilation of statistics. Unit level data collected for statistical purposes must be kept confidential by virtue of Section 24, Paragraph 1, Sub-paragraph 16 of the Act on the Openness of Government Activities (621/1999). According to Section 13 of the Statistics Act (280/2004), Statistics Finland may also release data for scientific studies and statistical surveys without data enabling direct identification. Statistics Finland may release data with their identification data to another Finnish statistical authority for the purpose of compilation of statistics on an activity falling within its sphere of influence, for cooperation between national statistical institutes, for cooperation between national statistical institutes, to the EuroGroups Register of multinational enterprises and to the Bank of Finland for the development, production, and quality improvement of the European statistics for which it is responsible. According to Section 12 of the Statistics Act, data describing the activities and public service production of central and local government authorities that are public based on other legislation are also public as statistical data. The collected data concerning individual persons are treated confidentially and they are used only for statistical purposes.

The data are protected against unauthorised access in accordance with the data protection rules adopted by Statistics Finland. The Statistics Act prohibits the use of data collected for statistical purposes in an investigation, surveillance, legal proceedings, administrative decision-making, or other similar handling of a matter concerning the enterprise. Unit-level data on enterprises may only be handled at Statistics Finland by persons whose tasks require the use of such data. Obligation to provide data

The obligation to provide data is based on Sections 14 and 15 of the Finnish Statistics Act (280/2004).

Notwithstanding the provisions on data secrecy, entrepreneurs are obliged to provide Statistics Finland with such data that are necessary for the compilation of statistics. By virtue of Section 21 of the Statistics Act, Statistics Finland is entitled to receive these data free of charge.

By virtue of Section 8 of the Statistics Act, data providers have the right to seek exemption from the obligation to provide data wholly or partially if the provision of data causes the respondent unreasonable inconvenience and the exemption will not essentially hamper the production of statistics or weaken the reliability and usability of statistics. Unreasonable inconvenience refers to putting the respondent in an unequal position with regard to other data providers. Duration of storage

Digital statistical data formed from the supplied data are permanently stored at Statistics Finland in accordance with the National Archives of Finland's confirmed storage period decision (KA/19843/07.01.01.03.01/2017).

About the data collection

Balance of payments statistics are based on Finland's statutory obligation to produce and report Balance of payments statistics to the European Central Bank (ECB) (ECB's guidelines ECB/2011/23) and to the Statistical Office of the European Union, Eurostat (Regulation of the European Commission No 555/2012) and to the International Monetary Fund (IMF).

Data collection service for enterprises
