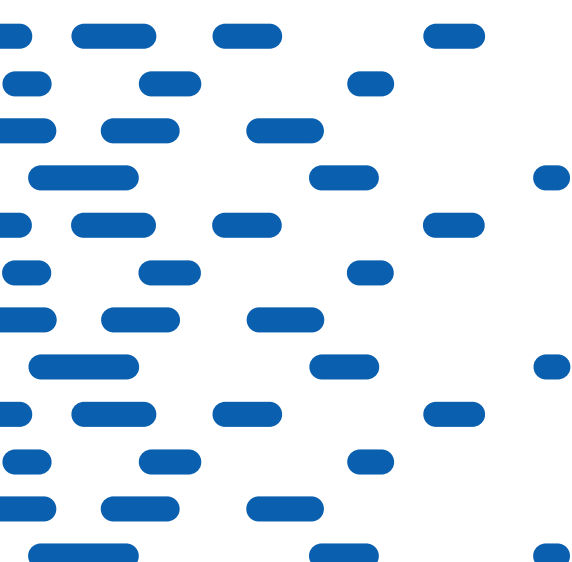

Responding is confidential

Statistics Finland is a government statistical agency, which produces statistics and conducts surveys describing conditions in society.

Grounds for processing personal data

Public interest as intended in the EU's General Data Protection Regulation.

Data to be combined with the collected data

To make responding easier, the collected data are supplemented with register data. Data to be combined are: data on education and occupation as well as demographic variables (e.g. age, registered sex, marital status, citizenship, native language and regional data).

Publicly available sources, Statistics Finland's database based on the Population Information System and those registers of authorities from which data are obtained based on the Statistics Act.



The data are processed so that you cannot be identified from the completed statistical data.

Disclosure of data

Statistics Finland never releases the data received by it to other authorities in a manner that would allow identification of the individuals having participated in the survey.

- We handle your responses in a confidential manner.
- Statistics Finland's employees are obliged to secrecy.
- We use the information you have given for compiling statistics on the use of information and communication technology by the population.
- It is not possible to identify persons having participated in the survey from the statistical data.
- Statistical data can be released for statistical surveys and scientific research.

Survey results benefit us all

The survey examines different ways of using computers and other information technology devices. In addition, questions are asked about the purposes of Internet use and the frequency of use. The survey also includes questions for persons who do not use the Internet, a computer or a mobile phone.

Based on the responses, we compile official statistics describing Internet use in Finland.

The survey is responded to once. The results are published as soon as the statistical data are completed in autumn 2025.

Data are collected from small pieces

Participation is a civil right. Your responses are utilised when preparing decisions that affect us all. By participating you help to ensure that decision-makers and central government have a view of Finnish society that is based on the right kind of information. All people benefit from this.

We want to ensure that all those selected randomly to the survey are given the opportunity to participate

The situation of each person drawn for the survey is important when describing the use of Internet, regardless of whether they use the Internet actively or not. If we cannot reach you, we can also try to contact you through another adult member of your household.

Thousands of persons aged 16 to 89 respond to this survey every year. You are one of those randomly selected and represent your age group and those living in your area. No one else can replace you.
