

### What are the data used for?

The data are used for calculating cost indices and price indices for agriculture. The indices are used for agreement and tariff negotiations between providers and buyers of services when assessing the price changes in the field. They are also utilised in connection with financial analyses and to support decision-making related to economic policies.

# Further information on the obligation to provide data and treatment of the data

### Confidentiality, data protection and publicity

Statistics Finland uses the data for the compilation of statistics. Unit level data collected for statistical purposes must be kept confidential by virtue of Section 24, Paragraph 1, Sub-paragraph 16 of the Act on the Openness of Government Activities (621/1999). According to Section 13 of the Statistics Act (280/2004), Statistics Finland may also release data for scientific studies and statistical surveys without data enabling direct identification.

Statistics Finland may release data with their identification data to another Finnish statistical authority for the purpose of compilation of statistics on an activity falling within its sphere of influence and for cooperation between national statistical institutes. The data are protected against unauthorised access in accordance with the data protection rules adopted by Statistics Finland. The Statistics Act prohibits the use of data collected for statistical purposes in an investigation, surveillance, legal proceedings, administrative decision-making or other similar handling of a matter concerning the enterprise. Unit-level data on enterprises may only be handled at Statistics Finland by persons whose tasks require the use of such data. ### **Duration of storage**

Digital statistical data formed from the supplied data are permanently stored at Statistics Finland in accordance with the confirmed storage period decision (KA/19843/07.0 1.01.03.01/2017) of the National Archives of Finland.

### About the data collection

The production of the index of producer prices of agricultural products and the index of purchase prices of the means of agricultural production is based on a long-term agreement with Eurostat, the Statistical Office of the European Union. The compilation of statistics is also indirectly based on the following acts: Regulation (EC) No 138/2004 of the European Parliament and of the Council on the economic accounts for agriculture, the act on rural business statistics (1197/1996), the act on the rural business register (1515/1994).
