Data to be combined with the collected data

To make responding easier and enable versatile research use of statistical data, the collected data can be supplemented with register data from different periods of time. The following data can be combined to the collected data: the respondents' and their household-dwelling unit members' year of birth, registered gender, marital status, family, residence and place of residence data, education and qualification data, income, benefit and employment data, occupation and workplace data, job search data, debt, tax and wealth data, mother tongue, nationality and country of birth, health and health care data. No names or personal identity codes are shown in the survey data. Unfinished answers can also be utilised in the data.



The data are processed so that you cannot be identified from the completed statistical data.


Statistics Finland has studied households' consumption since 1966. The latest survey was conducted in 2022, and it was used to produce statistics that are widely used in social decision-making.
